Thomas Drake a signer of Matthew Drake Appellee } On appeal from a judgment of a Justice of the peace, recovers against the appellant by the appellee the 12th day of April 1857 for \$29.50 with interest from the 26th day of March 1840, till paid and \$9.60.

This day came the parties by their attorneys, who being fully heard, and the evidence adduced maturely considered, it seems to the Court, that there is no error in the judgment aforesaid. Therefore it is considered that the same be affirmed and that the appellee recover against the appellant and Thomas Griffin his surety the amount thereof together with ten per centum per annum damages thereon from the aforesaid 12th day of April 1857, till payment and his costs by him about his defence in this behalf expended.

Ordered that the Clerk register Adeline Boon formerly a free negro born free in this County as appears to the satisfaction of the Court of Grantham Down, free negro, who was born free within County as appears by the testimony of Alexander Myrick.

Ordered that A. H. Burges, Const. B. Kello of Wm. R. Stephenson be appointed Commissioners to estimate at their discretion the repairs of the embankment at Round Hill bridge & receive the same when completed & make report to Court.

Ordered that the Court be adjourned till the first day of the next Term.
