On the motion of James H. Mangum, guardian of Edward W. Dunn he is allowed to expend the sum of fifty dollars of the principal of his ward's estate for his support for the year 1853, and sixty dollars of the principal for his support for 1854.

On the motion of James H. Mangum guardian of B. F. Dunn he is allowed to expend the sum of twenty five dollars of the principal of his ward's estate for his support for the year 1853, and sixty dollars of the principal for his support for 1854.

Ordered that Littleton McGlann Esq. of John McGlann and acting guardian to Indiana T. McGlann pay out of any funds in his hands belonging to said Indiana to Mary & Jas. N. McGlann \$67. 00 for her board & clothing for 10 months.

Ordered that Littleton McGlann Esq. of John McGlann dec'd, and acting guardian of James A. McGlann and John W. McGlann expend of any funds he may have in his hands belonging to his wards the sum of fifty dollars for the board & support of the said James A. McGlann & twenty five dollars for the board of the said John W. McGlann.

Ordered that James Maffitt guardian of David H., Sally V., Elizabeth S. and Henry Kindred (orphans of Henry Kindred dec'd) be hereby authorized to invest so much of the money & personal effects as may now be in his hands belonging to his said wards ^{or} either of them, or as may hereafter come into his hands, in Virginia State Stock or other ^{debtors} annual or semi-annual interest paying Stock as in his judgment may be to the interest of his said wards and account for the same in his settlements hereafter to be made.
