Jeremiah Nisbet his securities (who justified in oath as to their sufficiency) entered into and acknowledged above with penalty of eight thousand Dollars, conditioned according to law. Certificate is granted him for obtaining letters of administration on the estate of William H. Darrow deceased her due form.

Ordered that Jeremiah Nisbet, H. M. Smith, J. J. Spratt and Seth D. Williams a jury three of them being sworn for the purpose do appraise all the goods & chattels of William H. Darrow deceased that may be produced to them (and make due return of the same.
