- beginning every persons land in the said County both divide it into 39 parcels, as follows /
- Preamble etc. From Notoway River up the great swamp to Graffords road, down said road to Notoway river and down said river to the beginning.
2. From the North side of the flat swamp, from the old parish line, thence to the Cabin branch, and up that to the Angelia Swamp, up the same to Robins branch and up that to the flat swamp, and down the flat swamp.
 3. Bounded by the Micherrin River and the flat swamp and from the old parish line to the flat swamp and down to Thomas Cocks.
 4. Below Notoway River, Bangs Bridge road, the three creeks and the Bulfield road.
 5. All the lands lying east of the Darkum Swamp, Notoway River, the Indian line, and the Main Road sometimes called the Creek road -
 6. From the Angelia Swamp bridge, up the swamp to Townsons branch, up the said branch to the Angelia Chappell, then down Burnes road to the head of Buckhorn, down that to the new Road and by the said Road to the beginning.
 7. From the mouth of Reddys branch to the head of Georgis Branch, down that to the Rose meadows, up that to Robins branch, up that to the head of Angelia Swamp and down the said swamp to the beginning.)
 8. From Robins branch up the south side of the three creeks, to the County line, to the Micherrin River, down the said river to Thomas Cocks land and thence to Robins branch.
 9. From the former Parish line down the flat swamp to Graffords road and along the said road to the County line and up the said line to the Greenville line, up that to the old Parish line and along the said line to the beginning.
 10. From Graffords road down the flat swamp to the County line to Grafford long said road to the beginning.
 11. From the mouth of Blunts swamp to the mouth of Rose swamp, up that to the Indian line, down the said line to Graffords road, up the said road to Flat swamp, up the same to the beginning.
 12. From the Parish line at the Flat swamp down the said swamp to the Mouth of Blunt swamp up the same to the mouth of Rose swamp up that to the Indian line, along the said branch to Townsons branch thence down that to the Angelia Swamp and up that to the head of the Cabin branch, then down the said branch to the old Parish line then to the beginning.
 13. From the old County line to the south side of the Cypress swamp and up the same to Boons road along the said road to the County line down the said line to the County line and then to the beginning.
 14. From the County line at Boons road, up the said road to the mouth of Flat swamp, up that to Joseph Everett, thence along Taylors road to Hutchards path, thence down the said path to the Cypress swamp, down the said swamp to Boons road up the said road to the beginning.
 15. From Union Everett along Taylors road to Tuck Wahata swamp up the swamp to Graffords road, up said road to the Flat swamp and down and down the said swamp to the beginning.
 16. From the mouth of the great branch, up the said branch to the head, thence along the line of the Rⁿ Mr Gurley to the head of Dicks Swamp, then down the said swamp to the River up the said River to the mouth of Tuck Wahata Swamp up the said swamp to the beginning.
 17. From the mouth of Reddys branch to the head of Georgis Branch, down the said branch to Rose Meadow, up that to Robins branch, down the said branch to the three creeks down the three creeks to the mouth of the Angelia Swamp up the same to the beginning.)
 18. From the mouth of the three creeks, up the same to the mouth of the Hornet swamp
