- 20 From the mouth of the poplar swamp, up the same to the County line, up the
 said line to the three crakes and down the three crakes to the beginning -
- 21 From the buckhorn bridge, up the same to the old Indian line along the
 said line to Buckhorn road, up the said road to the beginning -
- 22 From Mundalls on the great road at the Flat swamp down the said
 swamp to the mouth of Cox's swamp up the said swamp to the road up the
 road to the beginning -
- 23 From the Notaway River North Carolina line to the old Anson road line.
- 24 Bounded by the old Anson road line, Black water & Anson road River.
- 25 From the lands lying on the East side of D. Browns road lying in the
 old Anson road line, thence up the black water to David Johnson's thence up
 the Pocomo side to the aforesaid road.
- 26 From all the lands of David Johnson on Black water river up the Cypress
 swamp to the road and down the road to the Pocomo line -
- 27 From all the lands on the West side of D. Browns road and up Notaway
 swamp to the old parish line, along the said line to the Cypress swamp
 and down the same to the road -
- 28 Between Notaway swamp, Notaway River and the old parish line.
- 29 All the lands between Black water black creek and the Cypress swamp
- 30 All the lands from the former parish line, between Black water & Seacoek
 to Franks bridge down Black Creek & Black Water.
- 31 From the old parish line to Broad water road and down the said road to
 Round hill swamp, down the same to the beginning -
- 32 From the broad road up Seacoek to the County line and thence to
 Black water and down Black water to the said road -
- 33 Between Round hill the light road and the County line.
- 34 Between Round hill, the black Creek, the Apamossuck and the County line.
- 35 Between the Apamossuck, Notaway River and the County line.
- 36 From the former parish line thence to the head of black Creek and the
 Apamossuck and down the swamp to Notaway River and down said river
 to the former parish line -
- 37 Between Seacoek, Black Water and Broad Water road.
- 38 Beginning at the mouth of Dicks swamp, up to the Bone road, along Bone road
 to the Cypress swamp, down that to Notaway River, up that to the beginning
- 39 The lands between Seacoek, Lightwood and the County line, and
