Deed of Trust from Arthur Pope to Benj. B. Kendrick bearing date October 7th 1858 conveying personal property, in trust to secure debts due Beaton & Harrison, was admitted to record October 7th 1858.

Deed of Bargain and Sale from Nancy Holt to Thomas Ridley bearing date October 15th 1858, conveying land was admitted to record October 15th 1858.

Deed of Bargain and Sale from James Fagor & Elizabeth his wife to John J. Kendrick bearing date October 15th 1858, conveying land, was admitted to record October 15th 1858.
