

The Account of John T. Parrell's guardianship of Hannibal Moore & Elizabeth H. Moore, John W. Harrison's Executorial Transactions on the estate of Henry Moore dec'd. & Adair R. Everett, Maderat Bradshaw's administration on the estate of William Raiford dec'd. Saint Luffm's Executorial Transactions on the estate of Albion Bradshaw, dec'd., W. A. Jones' guardianship of Helen L. Everett, Arington Gardner's Transactions as curator of Eli Jagers dec'd. James Drury's guardianship of Mary R. Simmons, William Thomson's administration on the estate of Polly Benson dec'd. (and an account of the debts & demands against Polly Benson dec'd. & her estate having severally been on much and upwards in the Clerk's office. and there being no exceptions thereto come examined, confirmed and ordered to be recorded.

The last Will and Testament of Catharine Adams dec'd. was proved by the oaths of G. W. Cloud & H. Williams, two of the subscribing witnesses thereto and ordered to be recorded. Wm. A. Jones, the executor thereof named appears in Court and refuses to take upon himself the burthen of the execution thereof. On the motion of Minchen Williams who made oath (and together with Wm. A. Jones, his security, (who justified on oath as to his sufficiency) entered into and acknowledges abrid in the penalty of three hundred dollars conditioned according to law, Certificate is granted him for obtaining letters of administration on the estate of the said Catharine Adams dec'd. with her will annexed in due form.

Ordered that Wm. A. Jones, Julius C. Harris and A. Williams, being sworn for the purpose do appraise all the goods & chattels of Catharine Adams dec'd. that may be produced to them for the due return of the same.

Martha Williams widow of Seth D. Williams dec'd. having relinquished & yielded up as his administrator in favor of Edward Rawls. On the motion of the said Edward Rawls who made oath (and together with Josiah P. Gay & Elijah Rawls, his securities, (who justified on oath as to their sufficiency) entered into and acknowledges abrid in the penalty of six thousand dollars conditioned according to law, Certificate is granted him for obtaining letters of administration on the estate of the said Seth D. Williams dec'd. in due form.

Ordered that Wm. C. Gay, John B. Higgins, W. W. Lawrence & Goodman C. Johnson, or any three of them, being sworn for the purpose, do appraise all the goods & chattels of Seth D. Williams dec'd. that may be produced to them & make due return of the same.
