Ordered that E. L. Story & Geo. C. Pope be allowed five hundred dollars each for their services in purchasing & distributing provisions to the families of the soldiers in Southampton County for the year ending 31st December 1864.

Let John R. Edwards be hereby appointed Commissioner to settle the accounts of the Agents appointed to purchase & distribute provisions to the soldiers, their families &c. and make report to the Court.
