 and acknowledged a bond in the penalty of five thousand dollars conditioned as the law directs certificate
 is granted her for obtaining letters of administration on the estate of Wm P Harris dec'd in due form.

Ordered that John Williams, James & Peter, Robert Rowlands & Fortunatus Daniel or any three of
 them being duly sworn for the purpose do appraise all the goods or chattels of Wm P Harris dec'd and
 have the appraisement under their hands to the Clerk of this Court.

 heretofore named in this Court who made oath and together with John W Noble her security (who justified

 E Bryant the Executor therein named who made oath and together with James J Pope his security (who justified
 on oath as to his sufficiency) entered into and acknowledged a bond in the penalty of One thousand dollars
 conditioned as the law directs certificate is granted him for obtaining a Probate of the said Will in due form.

The Court with assign Eliza V Davis guardian to Edgar W Clements & Davis coheirs of Adam
 S Davis dec'd and therefore the said Eliza V Davis together with Wm J Williams, Thomas Lewis,
 John A Davis, Ed W Davis Thomas M Pope & Orris Moore her securities (who justified on oath as to their
 sufficiency) entered into and acknowledged a bond in the penalty of five thousand dollars conditioned as the
 law directs.

As Writing purporting to be the last Will and Testament of John W Mather being dated the
 without date was produced in Court in order to be proved, and Benj J Bryant, James Pope and
 Henry Ferguson the subscribing witnesses having sworn & examined, the Court after hearing the testimony
 & opinion that the said John W Mather at the time of executing the said Writing was out of mind and
 lacking mind and memory, and therefore refused to admit the said Writing to record as the true last Will &
 Testament of the said John W Mather dec'd.

On the motion of Jacob Lewis who is desirous of clearing his lands by a deed to be cut through a part

 already called but came not. Therefore it is ordered that a writ in the nature of a writ of ad quod damnum be
 issued directed to the Sheriff of Southampton County to be executed according to law on the 25th day of October
 next and the inquest made in pursuance thereof together with the said writ to be returned to the next term
 of this Court.
