

1588 On the motion of Thomas Ridley against J. A. Bell, Jas. E. Schell, Jas. Dillond & H^{rs} A. Bell. This day came the plaintiff by his attorney and it appearing to the Court that the Defendants have had twenty days previous notice of this motion they were solemnly called but came not. Therefore it is considered by the Court that the plaintiff recover against the Defendants the sum of \$116.⁵⁰ being a sum equal to the interest for one year on the sum of \$1935.⁰⁰ principal debt due by the Defendants to the Plaintiff together with the Supt. & Bell's 1st debt at Bell's & the p^{ly} by said H. W. Briggs. And also that the plaintiff recover against the Defendants his costs by him in this behalf expended.
