 making an offer by fighting together at Carson's Point on the 14th July 1849,
 as the witness of Samuel Ferguson, who was sent for & duly sworn.
 James Nicholas (Clerk) for stealing horses of the value of \$12.00 from St. Patrick's
 St. James on the first of January 1850, as witness of St. Patrick St. James
 who was sworn as his own request. - Joseph Gregory (Clerk) for perjury
 as Franklin before St. William Mc. Commishner, on 21st July 1849,
 as the witness of J. H. Corp, Orin Morris, John St. Borge, who
 were sent for & duly sworn. - Frank Mc. Stoddard for perjury committed
 on the 14th day of July 1849, in taking two class bills after having
 sworn voluntarily in Confederate army, as the witness of John St.
 Borge, who was sent for & duly sworn. And the said Grand Jury having
 nothing further to present were discharged. -
