that it hereafter be proceeded in his name.

On the Motion of Patrick Ross. Ordered that the Administrators Estate of
Edward Rogers do be committed to the hands of J^{ts} L. & J. Shuff. &
J^{ts} County, to be administered according to law.

On the Motion of David W. Nicholson against W^m G. Gray, Guardian
of Richard, Nancy L. & Benjamin T. Gray. This day came the
parties by their attorney who being fully heard, it is ordered by
the Court that the said W^m G. Gray execute a bond with good
security in the penalty of Fifteen hundred dollars, conditioned according
to law, whereupon the said W^m G. Gray, with Joseph Gray & J^{ts} C.
Johnson his securities, (who jointly & severally as to their sufficiency)
tenders into & acknowledged a bond in the penalty of Fifteen
hundred dollars, conditioned according to law, which bond being
a stamp of the J^{ts} Sec. of the Dist. to the amount of one dollar
being affixed thereto & duly cancelled is ordered to be
recorded. It being sworn to that the value of the said Joseph Gray does
exceed the value of the said Thomas's demand — but exceed the
value of Fifteen hundred dollars. And it is ordered that
the said W^m G. Gray pay to the said J^{ts} Nicholson the
costs of this proceeding.

Ordered that John Applewhite, J^{ts} M. James, W^m P. P. & J^{ts} P. & J^{ts} P.
who are hereby appointed Administrators for the purpose of the said Rogers
do lay to the Court under taken the rebuilding of the Bridge off
the Court running from Mrs. Applewhite's stable pond, across the same
upon completion & report to Court.

David B. Kinard is appointed Surveyor of the road from Longforn
to Indian Swamp in the name of John Thomas, respondent. And
it is ordered that the usual bonds do work thereon.

Ordered that W^m A. Dole, J^{ts} L. Bailey & J^{ts} C. Barker, who
are hereby appointed Commissioners for the purpose, do lay to the
Court under taken the repairs of the Bridge on the Spanning
ick Swamp, on the Salisbury Road, across the same when
completed & report to the Court.

Ellis do be committed to the hands of J^{ts} L. & J. Shuff. &
