

Ordered that Amos Harris, Jefse Turner, Joshua Harris and Samuel Westbrook
or any three of them being first sworn before a justice of the peace for this county
do appraise in current money the slaves (if any) and personal estate of John
Sharples dead, and return the appraisement to the next court.

The last will and testament of Joshua Nicolson deed was proved by the oaths of Rebecca
Moore and Eunice Seward two of the witnesses thereto and ordered to be recorded.
Time being allowed the executors to qualify thereto.

Ordered that Henry Applewhite, Howell Myrick, Owen Myrick and James Jones or
any three of them being first sworn before a justice of the peace for this county do
appraise in current money the slaves (if any) and personal estate of Joshua Nicolson
dead and return the appraisement to the next court.

An indenture of feoffment between Hardy Bunn and Dorcas his wife of the
one part and Jacob Turner of the other part and the receipt thereon endorsed
were acknowledged by the said Hardy Bunn and Dorcas his wife she being
first privily examined as the law directs and ordered to be recorded.

The last will and testament of Thomas Edwards deed was proved by the oaths
of Thomas Newson and James Atkinson two of the witnesses thereto and ordered to
be recorded. The executors having time allowed them to qualify thereto.

Ordered that Jeremiah Drake, William Edwards, James Atkinson and Samuel
Story or any three of them being first sworn before a justice of the peace for
this county do appraise in current money the slaves (if any) and personal estate
of Thomas Edwards dead and return the appraisement to the next court.

John Barrow is by the court recommended to his Excellency the Governor as a
captain of the militia of this county in the room of John Myricks who has
resigned.

John Barrow appeared and took the oaths prescribed by law as a Captain
of company of militia of this county.

On the motion of Winnie Williams who made oath according to law certificated
is granted her for obtaining letters of administration on the estate of Micajah
Williams deed giving security at the next court.

Ordered that John Wilkinson, Lazarus Cook and Henry Taylor or any two of
them lett the rebuilding of flat swamp bridge near John Wilkinsons to the
lowest undertaker and make report thereof to this court.

An inventory of the estate of Sampson Revill deed was returned and ordered
to be recorded.

Samuel Westbrook is by the court recommended to his Excellency the Governor
as first Lieutenant of a company of militia commanded by Captain John
Barrow.

John Rogers is by the court appointed seconds lieutenant and Drury Harris
Ensign of a company of militia commanded by Captain John Barrow.

An indenture of feoffment between William Gressitt Executor de of Thomas
Gressitt deed of the one part and James Gressitt of the other part was acknow-
ledged by the said William Gressitt and ordered to be recorded.
