Whereupon the said James Hall and George Hall with Benjamin Turner and Laurence joined their securities entered into and acknowledged their bond in the penalty of Two thousand pounds for the said executors due and faithfull administration on the estate of the said decedent and performance of his will

Ordered that Arthur Bowing, Benjamin Hasty, David Denson and Joseph Bradshaw or any three of them being first sworn before a justice of the peace for this county do appraise in current money the slaves (if any) and personal estate of George Hall dead. and return the appraisements to the next court

Whereupon the said Isaac Williams with John Davis his security entered into and acknowledged their bond in the penalty of Ten thousand pounds for securing the said orphans estates and indemnifying this court

Ordered that the churchwardens of the parish of Pottersway bind out Jesse Williams Moore orphan of James Moore dead. according to law. William Urquhart and Mark Hudson are by the court appointed commissioners of the grain tax for the ensuing year
