Ordered that Jesse Whitehead, Titus Carr, John Gilliam and Jacob Barnes or any three of them being first sworn before a justice of the peace of this county do appraise in current money the slaves if any and personal estate of Thomas Everitt dead. and return the appraisement to the next court.

The last will and testament of George Hall dead. was presented in court by James Hall and George Hall the executors therein named, proved by the oaths of Laurence Joiner, Benjamin Hasty and John Hasty the witnesses thereto and ordered to be recorded. And on the motion of the said executors who made oath according to law certificate is granted them for obtaining a probate thereof in due form giving security. Whereupon the said James Hall and George Hall with Benjamin Turner and Laurence Joiner their securities entered into and acknowledged their bond in the penalty of Two thousand pounds for the said executors due and faithful administration on the estate of the said decedent and performance of his will.

Ordered that Arthur Bowing, Benjamin Hasty, David Denson and Joseph Bradshaw or any three of them being first sworn before a justice of the peace for this county do appraise in current money the slaves if any and personal estate of George Hall dead. and return the appraisement to the next court.

James Moore and Jesse Williams Moore orphans of James Moore dead. came into court and chose Isaac Williams their guardian. Whereupon the said Isaac Williams with John Davis his security entered into and acknowledged their bond in the penalty of Ten thousand pounds for securing the said orphans estates and indemnifying this court.

Ordered that the churchwardens of the parish of Notterway bind out Jesse Williams Moore orphan of James Moore dead. according to law. William Urquhart and Mark Hudson are by the court appointed commissioners of the grain tax for the ensuing year.
