Whereupon the said Thomas Harris and Sandy Harris with Jeremiah Dore and Moses McHenry their securities entered into and acknowledged their bond in the penalty of three thousand pounds for the said executors due and faithful administration in the state of the said decedent and performance of her will.

Ordered that Timothy Toppe, William Ridley, James Jones and Harris James or any three of them being first sworn before a Justice of the peace of this county do appraise in current money the slaves, if any, and personal estate of Mary Mynick dead, and return the appraisement to the next court.

An indenture of feoffment between Council Dick of the one part and John Jackson of the other part and the memorandum of livery of seisin thereon endorsed were acknowledged by the said Council Dick and ordered to be recorded.

An indenture of feoffment between Matthew Dick of the one part and John Jackson of the other part and the memorandum of livery of seisin thereon endorsed were acknowledged by the said Matthew Dick and ordered to be recorded.

Upon a recognizance entered into by Benjamin Adams to appear here this day the said Benjamin Adams for securing a bastard child on the body of Milly, Vaughan the said Adams appeared accordingly and with Matthew Morgan his security entered into and acknowledged themselves indebted to this our commonwealth in the sum of twenty five pounds to be levied of their respective lands goods & chattels and to the poor commonwealth rendered. Yet upon this condition that if the said Adams shall pay to the churchwardens of the parish of St. Luke such part of the aforesaid sum of twenty five pounds annually as they shall demand for the purpose of maintaining the said bastard child untill it shall arrive to lawful age to be bound out then the above recognizance to be void.

The warrant of the churchwardens of Rottonway parish against Drury Williams is quashed.

An indenture of bargain and sale between Moses Wood of the one part and Thomas Wood of the other part was proved by the oaths of John Pond and Stephen Pond two of the witnesses thereto and continued for further proof.

Upon the petition of William Hines Another Foster and John Powell against Henry Tiller it is ordered that unless the said Henry Tiller give the plaintiffs countersecurity before the next court that he then deliver up the estate for the redemption of the plaintiffs.

An indenture of bargain and sale between Benjamin Kirby and Anne his wife of the one part and John Simmons of the other part and the receipt thereon endorsed were acknowledged by the said Benjamin Kirby and Anne his wife she being first privately examined as the law directs and ordered to be recorded.

An indenture of feoffment between Howell Whittington and Rebecca his wife of the one part and John Roddelle of the other part and a memorandum of livery of seisin thereon endorsed were acknowledged by the said Howell Whittington and Rebecca his wife she being first privately examined as the law directs and
