John Payne } In Debt

This defendant being arrested and not appearing on the motion of the plaintiff by his attorney it is ordered that judgment be entered for the plaintiff against the Defendant and that he give security for his appearance for the debt in the declaration mentioned unless he shall appear and plead at the next Court.

Upon the petition of Micajah Griffin executor of Benjamin Griffin decd against William Mackie and Rawleigh Barritt for four pounds twelve shillings due by bond This day came the plaintiff by his attorney and the defendants having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered by the court that he recover against the said defendants the aforesd sum of four pounds twelve shillings and his costs by him in this behalf expended But this judgment except the costs is to be discharged by the payment of Two pounds six shillings and interest thereon from the 31st day of May 1782 till payment.

Upon the petition of Micajah Griffin ^{of Ben Griffin} against James Willson and William Binner for three pounds twelve shillings due by note This day came the plaintiff by his attorney and the defendant having been duly summoned and served with a copy of the petition and not appearing on the motion of the said plaintiff it is considered that he recover against the said defendants the aforesd sum of Three pounds twelve shillings and his costs by him in this behalf expended But this judgment except the costs is to be discharged by payment of One pound sixteen shillings and interest thereon from the 31st May 1782 till payment.

Upon the petition of Micajah Griffin executor of Benjamin Griffin decd against Richard Boyal and Lipo Bulls for one pound seven shillings one penny due by note This day came the plaintiff by his attorney and the defendants having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered that he recover against the said defendants the sum of one pound seven shillings and one penny and interest thereon from the 31st day of May 1782 till payment this costs by him in this behalf expended.

On the motion of Kiray Beldle a witness for John Bird against Sarah Pope it is ordered that the said Bird pay him fifty pounds of tobacco for two days attendance on this Court according to Law.
