money the slaves if any and personal estate of George Washington dec'd between the

been before proved by the two others is ordered to be recorded

Articles of agreement between Philip Davis, Joel Davis & Ann his wife of the one part &
Elizabeth Heath of the other part with a receipt thereon endorsed were proved by the oaths
of Rich^d. Pond and Thomas Pond two of the witnesses thereto ordered to be recorded

Articles of agreement between Hannah Davis, Joel Davis & Ann his wife & Elizabeth
his wife and Elizabeth ~~Heath~~ widow and relict of Rich^d. Heath of the one part &
Philip Davis of the other part were proved by the oaths of Rich^d. Pond & Thom^s. Pond two
of the witnesses thereto ordered to be recorded

Articles of Agreement between Philip Davis and Elizabeth Heath widow relict of the
one part and Ann Davis wife of Joel Davis of the other part were proved
by the oaths of Rich^d. Pond and Thomas Pond two of the witnesses thereto ordered to be recorded

Ordered that Jordan Denfon Shadrach Lewis and Joseph Mountfort or any two of them
examine state and settle accounts current of the estates of Henry Doppe, Christopher Wade,
Benjamin Deale and Robert Johnson make report thereof to the next Court
