An Indenture of bargain and sale between Wm Bryant and his son Benja Bryant of the one part and Benjamin Whitfield of the other part was acknowledged by the S. Benja & William Bryant the parties thereto and order'd to be recorded

An Indenture of feoffment between Matthew Weik and Sarah his wife of the one part and Josiah Worrell of the other part was acknowledged by the S. Weik & wife she being first privately examined at the Law Courts order'd to be recorded

An Inventory the Estate of Ann Brunschaw died was returned & order'd to be recorded
On the motion of Thomas Fitzhugh he is allowed till the first day of Jan. 1795 to complete his water grist mill

Ordered that John Simmons and Benja Stewart surveyors of the highway with the male labouring tithables belonging to their respective parishes open and clear a new road from the old road to the bridge lately erected over Holloway near Miles Runys
