 ordered that the defendant be released from the custody of the sheriff and the said de-
 fendant by his attorney prays and has leave to impeach till the next court
 Upon a recognizance entered into by Elias Hobbs to appear here this day for begesting a bastard
 child on the body of Lucy Scarborough the said Elias Hobbs appeared accordingly and
 with Benjamin Blunt and Benjamin Stewart his securities acknowledged themselves
 indebted to the churchwardens of the parish of Nottoway that is to say the saids Elias
 Hobbs in the sum of Twenty five pounds and his securities in the sum of twenty five
 pounds each to be levied of their respective goods and chattels lands and tenements and
 to the said churchwardens rendered. Yet upon this condition that if the said Elias Hobbs
 shall pay such part of the aforesaid sum of Twenty five pounds to the churchwardens of
 the parish of Nottoway annually as they shall demand for the purpose of maintaining
 the said bastard child till it arrives to a proper age to be bound out then this recognizance
 to be void &c to remain in full force power and virtue

 defendant Thomas Bailey this day accordingly brought the body of the said defendant

 the said defendant committed to the custody of the sheriff. Whereupon Reuben
 Whitfield came into court and undertook for the said defendant that in case he
 should be cast in this suit he shall pay and satisfy the condemnation of the court
 or render his body to prison in discharge thereof or that he the said Reuben Whitfield
 will do it for him whereupon it is ordered that the defendant be forthwith released from
 the custody of the sheriff, and the said defendant saving to himself all advantage of
 the plaintiffs writ as to the declaration by his attorney prays and
 has leave to impeach till the next court.
