Ordered that Owen Myrick, Conwell Myrick, John Applewhite and John Pease or any three of them being first sworn before a justice of the peace of this court do appraise in current money the slaves (if any) and personal estate of William Conner and return the appraisement to the next court.

Whereupon the said Simon Marfee with Josiah Vicks and Joseph Mowbray his securities entered into and acknowledged their bond in the summe of four hundred pounds for securing the said orphans estates and indemnifying the court.

On the motion of Henry Browne security for Benjamin Wood executor of the last will and testament of Joshua Wood decd. for countersecurity Arthur Eason is accepted as security in the room of the said Henry who is discharged.

Josiah Vicks is by the court appointed to take the list of taxable property in the district formerly taken by John Whitehead.

Stephen Summerville having been summoned to give countersecurity for his guardianship of the orphans of Simon Stephenson decd. and failing to attend it is ordered that Arthur Boykin take the guardianship of the said children on himself.

Ordered that Dresly Barrett be summoned to attend at the next court.
