The last will and testament of William Vick was presented on Court by Lewis Vick and Pelgrim Vick the Executors named and proved by the oaths of John Jackson and Darius Vick one of the witnesses thereto and ordered to be recorded

And on the motion of the said Executors who affirmed according to Law being after people called quakers a certificate is granted them for obtaining a probate thereon in due form giving security Whereupon the said Executors with Jesse Vick and James Barnes their securities entered into and acknowledged their bond in the penalty of Two thousand pounds for the S. Executors due and faithful administration on the S. decedent's estate & performance of his will

Richard Muske returned his account of the profits & disbursements of the estates of John Muske & Matthew Muske orphans of Rich. Muske decd which were examined by the Court and found to be by the S. guardian approved & ordered to be recorded

Pesley Bonnett came into Court and chose Richard Kelso for his guardian Whereupon the said Richard Kelso with Wm. Ingham his security entered into and acknowledged their bond in the penalty of Two thousand pounds for securing the S. orphan's estate & indemnifying the Court

An Indenture of bargain and sale from Elizabeth Coston of the one part and Hannah Westbrooke of the other part with a memorandum thereon were proved by the oaths of John Barrow Thomas Turner & John Barrow these of the witnesses thereto & ordered to be recorded

Ordered that the churchwardens of the parish of St. Luke bind out William & Simon Turner orphans of Thomas Turner according to a Law

A writing purporting the disposition of the personal estate of Jacob Turner decd was proved by the oaths of John Pussell and Jacob Turner & two of the witnesses who put the same into writing at the request of the Testator which is ordered to be recorded Benjamin Blount Junr. procured a Commission to be high sheriff of this county the oath appointed by Law to a sheriff that he give bond according to the Law
