Turner for one pound ten shillings and interest due by note. This day came the plaintiff by
her attorney and the defendant having been duly summoned and served with a copy of the
petition and not appearing on the motion of the plaintiff it is considered by the court that
she recover against the defendant one pound ten shillings with interest thereon to be com-
puted after the rate of five per centum per annum from the 7th day of March 1785 till
payment and her costs by her on this behalf expended.

Elizabeth Person Plaintiff ? In Debt

This day came the parties by their attorneys and the defendant withdrawing
his former plea saith that he cannot gainsay the plaintiff's action, nor bat that he doth

Martha Turner administratrix &c of Arthur Turner deceased Plaintiff ? In Debt
against William Jones and Jethro Jones Doff.

This day came the plaintiff by her attorney, and the defendant William
Jones being returned no inhabitant it is ordered that this suit abate as to him, and the de-
fendant Jethro being solemnly called and not appearing on the motion of the plaintiff it is
ordered that the conditional judgment obtain'd against him and Bony? Blunt Crat?,
high sheriff of this county security for his appearance, at the last court be confirmed for
Twenty two pounds thirteen shillings the debt in the declaration mentioned. Therefore it is
considered by the court that the plaintiff recover against the defendant Jethro and Bony?
Blunt Twenty two pounds thirteen shillings and her costs by her about her suit on this
behalf expended and be in mercy &c. But this judgment except the costs is to be discharged
by the payment of Eleven pounds six shillings and six pence with interest thereon to
be computed after the rate of five per centum per annum from the 5th day of March
1784 till paid
