136th to 141st Upon the petition of William Bennett & Co. against William Rose for Two pounds twelve shillings and ten pence half penny due by account and costs. This day came the plaintiff by their attorney and the defendant having been duly summoned and served with a copy of the petition and account and not appearing on the motion of the plaintiff it is considered by the court that he recover against the defendant Two pounds twelve shillings and ten pence half penny and their costs by them in this behalf expended.

136th to 141st Upon the petition of James Turner assignee of Nathan Harris against Bradford Kinsum and Samuel Blake for Four pounds due by bond and costs. This day came the plaintiff by his attorney and the defendants having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered by the court that he recover against the defendants four pounds and his costs by him in this behalf expended. But this judgment except the costs is to be discharged by the payment of Two pounds with interest thereon to be computed after the rate of five per centum per annum from the 3rd day of January 1784 till paid.

136th to 141st Upon the petition of Jeremiah Drows against John Dey and Henry Thomas for three pounds one shilling due by a bill penal and costs. This day came the plaintiff by his attorney & the defendants having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered by the court that he recover against the defendants three pounds one shilling and his costs by him in this behalf expended. But this judgment except the costs is to be discharged by the payment of one pound ten shillings and six pence with interest thereon to be computed after the rate of five per centum per annum from the 25th day of December 1778 till paid.

136th to 141st Upon the petition of Jeremiah Drows against David Hines and John Bland for three pounds fourteen shillings and six pence due by bill penal and costs. This day came the plaintiff by his attorney and the defendant John having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered by the court that he recover against the defendant John Bland three pounds fourteen shillings and six pence and his costs by him in this behalf expended. and the defendant David being returned no inhabitant it is ordered that this petition abate as to him. But this judgment except the costs is to be discharged by the payment of one pound seventeen shillings and three pence with interest thereon to be computed after the rate of five per centum per annum from the 25th day of December 1778 till paid.

136th to 141st Upon the petition of Jeremiah Drows Esq. ex or Nondum Drows dead, against Thomas Hedges for two pounds eighteen shillings due by bond and costs. This day came the plaintiff by his attorney and the defendant having been duly summoned and not appearing on the motion of the plaintiff it is considered by the court that the plaintiff recover against the defendant two pounds eighteen shillings and his costs by him in this behalf expended. But this judgment except the costs is to be discharged by the payment of one pound nineteen shillings with interest thereon to be computed after the rate of five per centum per annum from the 25th day of December 1778 till paid.
