On the motion of Patty Rose a witness for Robert Washington against William Whitehead executor &c of Edmund Day deed it is ordered that the said Robert Washington pay her three hundred and fifty pounds of tobacco for fourteen days attendance on this court according to law.

On the motion of Evans Rose a witness for Robert Washington against William Whitehead executor &c of Edmund Day deed it is ordered that the said Robert Washington pay him seventy five pounds of tobacco for three days attendance on this court according to law

The last will and testament of Samuel Vick deed was presented in court by Nathaniel Vick and Nathan English the executors therein named, proved by the oaths of Drury Beale and Edmund Ashley the witnesses thereto and ordered to be recorded. And on the motion of the said executors who made oath according to law certificate is granted them for obtaining a probat thereof in due form giving security. Whereupon the said Nathaniel Vick and Nathan English with Holladay Acwill their security entered into and acknowledged their bond in the penalty of five hundred pounds for the said executors due and faithful administration on the estate of the said decedent and performance of his will

Ordered that Jeremiah Drake, Drury Beale, William Thomas and John Rockelle or any three of them being first sworn before a justice of the peace of this county do appraise in current money the slaves (if any) and personal estate of Samuel Vick decd. and return the appraisement to the next court

An indenture of lefftment between Joshua Westbrook of the one part and Hannah Westbrook of the other part with the memorandum of livery of seisin and the receipt whereon ordered were acknowledged by the said Joshua Westbrook and ordered to be recorded

Rachel Drorit orphan of William Doornit decd. came into court and chose John Grindell jr. for her guardian. Whereupon the said John Grindell jr. with John Claude his security entered into and acknowledged their bond in the penalty of two hundred & fifty pounds for the said John securing the estate of the said Rachel and indemnifying the court

An indenture of bargain and sale between Trial Bailey and Martha his wife of the one part and Jonathan Loker of the other part was acknowledged by the said Trial Bailey and Martha his wife she being first privately examined at the law dñeeth and ordered to be recorded
