This day came the plaintiffs by their attorney and the defendant Moses having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiffs it is considered by the court that they recover against the said defendant two pounds two shillings and five pence together with interest thereon to be computed after the rate of five per centum per annum from the 1st day of December 1776 till payment and their costs by them in this behalf expended, and the defendant Hardy Beale being returned *re* inhabitant it is ordered that this petition abate as to him

On the motion of Elijah Brooker a witness for Robert Washington against William Whitehead *Exor. ve.* of Edmund Day dead. in an action on the case it is ordered that the said Robert Washington pay him four hundred forty two pounds of tobacco for ten days attendance on this court travelling sixteen miles four times in coming and the same in returning according to law.
