Therefore it is considered by the court that the plaintiff recover against the defendant his damages aforesaid in form aforesaid assented and his costs by him about his suit in this behalf expended and the said defendant in mercy.

On the motion of Peromeah Tyler a witness for Isham Newsum against William Edmunds it is ordered that the said Isham Newsum pay him one hundred pounds of tobacco for four days attendance on this court according to law.

On the motion of Elijah Crocker a witness for Isham Newsum against William Edmunds it is ordered that the said Isham Newsum pay him Eight hundred and five pounds of tobacco for thirteen days attendance on this court and travelling and returning sixteen miles ten times according to law.

On the motion of John Powell a witness for William Edmunds at the suit of Isham Newsum it is ordered that the said William Edmunds pay him Four hundred and seventy five pounds of tobacco for nineteen days attendance on this court according to law.

On the motion of Thomas Newsum a witness for Isham Newsum against William Edmunds it is ordered that the said Isham Newsum pay him one hundred and twenty five pounds of tobacco for five days attendance on this court according to law.

On the motion of Beverly Booth a witness for Nathaniel Kitchen against Etheldred Kitchen it is ordered that the said Nathaniel Kitchen pay him Fifty pounds of tobacco for two days attendance on this court according to law.

On the motion of Richard Deloach a witness for Isham Newsum against William Edmunds it is ordered that the said Isham Newsum pay him seventy five pounds of tobacco for three days attendance on this court according to law.
