

Upon the petition of Edwin Gray against Richard Blom and Stephen Williamson for two pounds fifteen shillings with interest due by note and costs. This day came the plaintiff Daniel Fisher his attorney and the defendant Richard Blom having been duly summoned and served with a copy of the petition and not appearing on the motion of the plaintiff it is considered by the court that he recover against the defendant Two pounds fifteen shillings with interest thereon from August 1st 1778 till paid and his costs by him in this behalf expended, and the defendant Stephen Williamson being returned no inhabitant it is ordered that this petition abate as to him.

Upon the petition of Charles G. Willford against William Rose for Three pounds twelve shillings due by specialty and costs. This day came the plaintiff by his attorney and the defendant having been duly summoned and served with a copy of the petition and not appearing. On the motion of the plaintiff it is considered by the court that the recover against the defendant Three pounds twelve shillings and his costs by him in this behalf expended. But this judgment except the costs is to be discharged by the payment of one pound sixteen shillings with interest thereon from June 25th 1778 till paid.

Upon the petition of William Ridley against Benjamin Newsum for two pounds two shillings and six pence due by note and costs. This day came the plaintiff by his attorney and the defendant having been duly summoned and served with a copy of the petition and not appearing. On the motion of the plaintiff it is considered by the court that he recover against the defendant Two pounds two shillings and six pence and his costs by him in this behalf expended. But this judgment except the costs is to be discharged by the payment of one pound eleven shillings and three pence with interest thereon from the 15th day of October 1784 till paid.

The petition of David Pines against William Blunt Esqr. &c of Jesse Drows dead is ordered to be dismissed.

Henry Blunt against Arthur Turner & Arthur Waller Defts. *Ptff* On a bond given to replevy the effects of the defendant Turner taken by virtue of a writ of fieri facias issuing on a judgment obtained in this court by the plaintiff against the said defendant.

On the motion of the plaintiff by his attorney and by virtue of the act of Assembly in that case made and provided the defendants having had legal notice hereof execution is awarded the plaintiff against the estate of the defendants for Fifteen pounds eighteen shillings one penny half pence with interest thereon from Septbr 28th 1785 till paid and for his costs by him in this behalf expended.

William Murrik and Randolph Newsum Exors. &c of Jeremiah Drows dead. against Richard Blom & Theophilus Scott. *Ptffs* On a bond given to replevy the effects of the defendant Blom taken by virtue of a writ of fieri facias issuing on a judgment obtained in this court by the plaintiff against the said defendant.

On the motion of the plaintiff by their attorney and by virtue of the act of Assembly in that case made and provided the defendants having had legal notice hereof execution is awarded the plaintiffs against the estate of the defendants for Five pounds with interest thereon from June 9th 1785 till paid according to the condition of the bond aforesaid and for their costs by them in this behalf expended.

Charles Capel against Elizabeth Smith. Executors of James Taylor dead. & James Magee. *Ptff* On a bond given to replevy the effects of James Taylor in the hands of the defendant Elizabeth taken by virtue of a writ of fieri facias issuing on a judgment obtained in this court by the plaintiff against the said defendant.

On the motion of the plaintiff by his attorney and by virtue of the act of Assembly in that case made and provided the defendants having had legal notice hereof execution is awarded the plaintiff against the estate of James Taylor in the hands of the defendant Elizabeth, and James Magee for Ten pounds sixteen shillings and five pence with interest thereon from August 12th 1785 till payment according
