An indenture of bargain and sale between Peter Barr of the one part and William Bryant of the other part was proved by the oaths of William Bryant, Thomas Everitt and Eum Everitt three of the witnesses thereto and ordered to be recorded.

A mortgage from Benjamin Waller to Luther Waller and the endorsement thereon were proved by the oaths of Daniel Fisher, John Wright and Charles Briggs the witnesses thereto and ordered to be recorded.
