Henry Thomas is appointed surveyor of the highway in the room of Drury Harris who is discharged from that office and it is ordered that the said Henry Thomas with the male labouring titheables belonging to the said road keep the same in repair according to law.

Ordered that Elisha Darden, Joshua Gardner, William Wester and Holland Darden or any three of them being first sworn before a justice of the peace of this county impartially to perform the service, view the conveniences and inconveniences attending the opening of a road from the road by William Wester to the new bridge at South Quay, and make report thereof to this court.

Ordered that Benjamin Cuffin and Charles Briggs examine, state and settle an account current of the estate of Daniel Pond decd. and make report thereof to this court

An account current of the estate of Daniel Pond decd. was reported by the persons appointed to examine state and settle the same and ordered to be recorded.

Henry Gardner is appointed surveyor of the highway leading from the old fork near his own house to South Quay bridge, and it is ordered that he with the male labouring titheables belonging to the said road keep the same in repair according to law.

Jordan Williams is appointed surveyor of the highway from the old county line to Henry Gardner's and it is ordered that he with the male labouring titheables belonging to the said road keep the same in repair according to law.

Matthew Jones is appointed surveyor of the highway from his own ferry to Doctor Brown's road and it is ordered that he with the male labouring titheables belonging to the said road keep the same in repair according to law.

An inventory and appraisement of the estate of Owen Myrick decd. was returned and ordered to be recorded.

William Hart is appointed surveyor of the highway from the sandy ridge road to Jones' ferry and it is ordered that he with the male labouring titheables belonging to the said road keep the same in repair according to law.

Ethelred Warren is appointed surveyor of the highway from the county line near Wynde to the hill at Beam creek and from thence to the county line near George Williams, and it is ordered that he with the male labouring titheables belonging to George Williams, Edward Lang, William Barrod, Ladd Barrod, Robert Adams and to himself keep the said highway in repair according to law.

John Bishop is appointed surveyor of the highway from the cross roads near Mr. Allen's quarter to the top of the hill on the south side of beam creek, and it is ordered that he with the male labouring titheables belonging to Robert Lawrence, Abrahams Williams, Robert Peworth, Joseph Scott, Isaac Williams and to himself keep the said highway in repair according to law.
