Sam a negro man slave belonging to Henry Westbrooke was brought before the court by the sheriff to whose custody he was heretofore committed on suspicion of felony and no person appearing to prosecute it is ordered that he be forthwith discharged out of custody.

Ordered that the overseers of the poor in the lower district of St Lukes parish bind out Michael Heathcocke a poor child of Sarah Bird according to law.

Ordered that the overseers of the poor in the upper district of St Lukes parish bind out Enos James orphan of Abner James dead according to law.

An indenture of bargain and sale between Joseph Penrise and Ann his wife of the one part and Francis Penrise of the other part was acknowledged by the said Joseph Penrise and Ann his wife she being first privately examined as the law directs and ordered to be recorded.

An indenture of bargain and sale between Arthur Joiner and Sarah his wife of the one part and William Ingram of the other part was acknowledged by the said Arthur Joiner and ordered to be recorded.

Rebecca Edwards orphan of John Edwards dead. came into court and chose James Brantley for her guardian. Whereupon the said James Brantley with Francis Penrise his security entered into and acknowledged their bond in the penalty of two thousand pounds, for his faithful execution of his office.

Lewis Joiner jr produced a list of indents received from the several persons against whose names they are extended and made oath to the same, whereupon it is ordered that the said list be certified according to law.

John Day orphan of Edmund Day dead. came into court and chose John Kindred for his guardian. Whereupon the said John Kindred with Cordal Bygnum his security entered into and acknowledged their bond in the penalty of one thousand pounds for his faithful execution of his office.
