

Ordered that Edmund Tyler and Thomas Holliday examine state & settle an account current of the estate of Wm George died & make a report thereof to this Court.

Ordered Samuel Jones John Sansteadphun & Arthur Bowring or any two of them examine state and settle an account current of the estate of Charles Powers died & make their report on the petition of Thomas Potts for leave to turn a road near his house it is ordered that Joshua Hoop Arthur Applewhite Dolphin Drew & Tho^s Redley or any three of them being first sworn before a justice of the peace impartially to perform the service view the conveniences & inconveniences of turning the S^d road & make report thereof to the Court.

On the motion of In^t Simmons his negroes Bacchus & Peggy are exempted from the payment of taxes for the year 1786 & in future (on account of old age & infirmities).

Ordered that John Barrow Thomas Turner & Henry Turner or any two of them examine state & settle an account current of the estate of Abiam Johnson died & make report thereof to the Court.

On the motion of Jordan Jenkins & Samuel Kello securities for Rich^d Bailey ex^{or} of Barnaby Bailey died it is ordered that he be summoned to appear at the next court ^{County} give security for his administration And it is ordered in the mean time that the S^d Jenkins & Kello take the said estate of Barnaby Bailey into their possession for their administration until the further orders of this Court.

An account current of the estate of Sampson Turner died was reported & ordered to be recorded.

Ordered that the overseers of the poor in the lower district of St Lukes parish bind out Michael Blow orphan of Benjamine Blow to John Blow according to law.

It being represented to the Court that the estate of Mary Bailey is wasting no person offering to take administration on the same it is ordered that Jordan Jenkins take the same into his possession and administer the same according to law until some person ^{qualified} to the administration appears.

An aut. current of the estate of Wm George died was reported & ordered to be recorded.

Joseph Bishop who was summoned to give counsel security for his guardianship of John George orphan of Wm George this day appeared and with Wm Wells entered into recogno^uances & their bond in the penalty of two hundred pounds for securing the estate of the S^d George and indemnifying the Court — Whereupon Deputy Booth the former security is discharged.

Ordered that the Treasurer of this County pay to Thomas Mearns four Nine pounds nineteen shillings and six pence for building a bridge over Nalloway swamp near Jones mill the person appointed to view the same reporting it was ^{found} ~~found~~ according to agreement.

David Washington is appointed a constable in the room of Abraham Jones who on his motion is discharged & the S^d Washington qualified accordingly.

Ordered that Peper Canell Harbrell Bailey Charles Bailey & Peter Bailey or any three of them being first sworn before a justice of the peace to appraise in current money the value of any personal estate of Mary Bailey died & deliver the appraisement to the next Court.

Neib^s Williams is by the Court appointed surveyor of the road in the room of John Redley who is discharged. It is ordered that he with the male labouring likeliest in his precinct keep the S^d road in repair according to law.
