On the motion of Jordan Judkins & Samuel Killo securities for Rich^r Bailey in the sum of £2000
by Bailey deceased it is ordered that he be summoned to appear at the next court to
give security for his administration. And it is ordered in the mean time that the said
Judkins & Killo take the said estate of Barnaby Bailey into their possession for their wisdom
discretion until the further orders of this Court.

An account current of the estate of Sampson Turner deceased was reported & ordered to be
settled

Ordered that the overseers of the poor in the lower district of St. Lukes parish bind
out Michael Blow orphan of Benjamin Blow to John Blow according to law

It being represented to the Court that the estate of Henry Bailey is wasting & no person having to
take administration on the same it is ordered that Jordan Judkins take the same into
his possession and administer the same according to law until some person be settled
to the administration appears.

An account current of the estate of W^m George deceased was reported & ordered to be settled

Joseph Bishop who was summoned to give count & security for his guardianship of the estate of the
orphan of W^m George this day appeared and with £1000 entered into & acknowledged
their bond in the penalty of two hundred pounds for securing the estate of the said George
and indemnifying the court — Whereupon Beulah Booth the former security is discharged

Ordered that the Treasurer of this county pay to Thomas Mowen that Nine pounds
nineteen shillings and six pence for building a bridge over Nollaway swamp near
Jones mill the person appointed to view the same reporting it was finished accordingly

David Washington is appointed a constable in the room of Abram Jones who on his
motion is discharged & the said Washington qualified accordingly

Ordered that Pepe Carrill Hartwell Bailey Charles Bailey & Peter Bailey or any
three of them being just soon before a justice of the peace to appraise in current
money the slaves of any personal estate of Mary Bailey deceased & value the appraiser
ment to the next Court.

Rich^r Williams is by the Court appointed surveyor of the road in the room of
Aster Kelly who is discharged & it is ordered that he with the male labouring
lithates in his present keep the said road in repair and may be law
