Robt. Pick & Robt. Pick, executors of Mary Pick, plff agst Stephan Johnson & Hardy Pope, deft. On a bond given to repay the estate of the S^r Stephen Johnson, & virtue of a process issued on a judgment obtained in this court by the plff v. the S^r defendant.

On the motion of the plaintiffs by their attorney they virtue of the act of Assembly in that case made and provided execution is awarded the plaintiffs agst the S^r defendants for three pounds thirteen shillings four pence interest thereon at the rate of 5% per annum from the 30th of July 1787 till payment according to the condition of the bond afores^t. & for their costs by them in this behalf expended.

Jacob Newsum having obtained an attachment agst the estate of Icham Atkinson who hath privately resided himself or so abcombe that the ordinary process of the law cannot be served upon him for a debt due to him from the S^r Atkinson. This day came the plaintiff by his attorney to the sheriff making return that he had executed the attachment in the hands of Lazarus Cook and the S^r garnisher appearing & deposing that he has in his hands belonging to the defendant seven pounds ten shillings before pence in money. He not appearing to repay the attached property. Wherefore on the motion of the plaintiff who is considered by the court that he is due agst the S^r defendant for nine pounds eight shillings three pence forth from the day of till paid & his costs by him in this behalf expended. And it is ordered that the garnisher pay the sum for his hands to the plaintiff towards satisfaction of this judgment & costs.

Briggs & Bailey plff agst S^r Hood & Henry Dales deft. On a bond given to repay the estate of the S^r J Hood & Henry Dales deft. of Hood.

Execution is awarded the plaintiffs against the S^r defendants for five pounds ten shillings & ten pence half penny interest thereon at 5% from the 23rd July 1787 till payment according to the condition of the bond afores^t. & for his costs &c

Icham Newsum plff agst Edmund Lester & Juⁿ Wood deft. On a bond given to repay the estate of the S^r Edmund Lester & Juⁿ Wood deft. of Edmund Lester & Co.

Execution is awarded the plaintiffs agst the S^r defendant for Five pounds eight shillings & eight pence and interest from the 23rd July 1787 till payment according to the condition of the bond afores^t. & also for his costs &c

Thomas Applewhite plff agst Wm Gwaltney & J. W. Lathon deft. On a Bond given to repay the estate of the S^r Gwaltney.

Execution is awarded the plaintiff against the defendant for six pounds and ten pence interest from the 26th July 1787 till payment according to the condition of the bond afores^t. & for his costs by him in this behalf expended.

Henry Vaughan plff agst Elizabeth Murfee deft. On an attachment.

Elizabeth Murfee deft. Joseph Pick came into court and under oath for the deft. that in case she is cast in this suit she shall pay certainty the consumption of the court & cause her body to remain in the charge thereof or that he the S^r Pick will do it for her expenses.
