James Newsum having obtained an attachment agst the estate of John Atkinson who hath privately removed himself or so absconded that the ordinary process of the law cannot be served upon him for a debt due to him from the S^d Atkinson. This day came the plaintiffs by his attorney & the sheriff making return that he had executed the attachment in the hands of Legans fork and the S^d garnisher appearing & deposing that he had in his hands belonging to the defendant seven pounds ten shillings eleven pence in money & he not appearing to depose the attached property. Therefore on the motion of the plaintiffs who is awarded by the Court that he recover agst the S^d defendant for nine pounds eight shillings & three pence interest from the day of the said judgment till paid & his costs by him in this behalf expended. And it is ordered that the S^d garnisher pay the sum for his hands to the plaintiffs towards satisfaction of this judgment & costs
