Ordered that James Harris James Schell William Simmons of Ino James be added to Job Lewis Ino Russ Jeph Holt Charles B Nicholas formerly appointed to appraise the estate of Francis Clements and that the persons afores^d or any three of them do appraise the said estate & return the same to Timothy Atkinson who was sworn as a grand juror and failed to appear, having this Simon Baykin made suffice
