Ordered that the Overseers of the poor for this county do bind out Edmunds Peter and Benjamin Miles for children to Jeremiah Holt according to law.

On the motion of David Bryant who made oath according to law for administration on the estate of William Anderson etc. the same is granted him on his giving bond and security whereupon the said David Bryant with Nathan Pope and Clark William his Sureties entered into and acknowledged their bond in the penalty of two thousand dollars conditioned as the law directs.

Ordered that James Powell John Whithead Henry Peter and Benjamin Davis or any three of them being first sworn before a Justice of the Peace for this county as appraisers in current money the slaves of any and personal estate of William Anderson etc. and return the appraisement to the Court.

Elizabeth Harris is by the Court appointed guardian to Sally and Abigail Westbrock orphan of John Westbrock etc. and thereupon the said Elizabeth Harris with Samuel Turner and Roswell Prouty entered into and acknowledged their bond in the penalty of one thousand dollars with conditions according to law.

William Hays guardian of Abigail Harris produced an account of said orphan estate which account was presented and allowed by the Court. Doorn to by the guardian and same to be recorded.
