Ordered that Arthur Williamson, Thomas Williamson, & William Williamson, being first sworn before a Magistrate of this County, do appraise in current money the slaves of any and personal estate of Aaron Sharp deceased and return the appraisement to the Court.

On the motion of Absalom Reese who make oath and together with Thomas Applewhite and George Key, his securities entered into and acknowledged their bond in the penalty of Two Thousand dollars conditioned as the law directs Certificate is granted him for obtaining letters of administration on the estate of Tally Reese deceased in due form.

Ordered that Benjamin Joy, Thomas Bate, Lewis Reese, Joseph Reese and John Reese or any three of them being first sworn before a Magistrate of this County, do appraise in current money the slaves of any and personal estate of Tally Reese deceased and return the appraisement to the Court.

On the motion of Henry Tette who make oath and together with Thomas Pope and William Copell his securities entered into and acknowledged their bond in the penalty of Five Thousand dollars conditioned as the law directs Certificate is granted him for obtaining letters of administration on the estate of Randolph Tette deceased in due form.

Ordered that Nathaniel Fates, Joel Lee, Abraham Nickelson and Eliza Nickelson or any three of them being first sworn before a Magistrate of this County, do appraise in current money the slaves of any and personal estate of Randolph Tette deceased and return the appraisement to the Court.

Elizabeth Turner the executrix named in the last will and Testament of Joseph Turner deceased, her late husband, who make oath thereto and together with James Jackson and Richard Harrison & her securities entered into and acknowledged their bond in the penalty of Five Thousand dollars conditioned as the law directs Certificate is granted her for obtaining a probat though in due former liberty is reserved for the Executors in the said will named to join in the probat when they shall think fit.

John Harris Jr who is charged on oath by Elizabeth Ann Harrison in this County single Woman with being the father of her bastard Child and stands bound by a recognizance to appear here and shew by and perform the order of this Court concerning the same and the said Defendant being solemnly called and not appearing it is heard that this prosecution be continued till the next Court.
