Now with the mill annuity of Benjamin Edwards deceased and administrator with the mill annuity of Richard Edwards deceased and administrator of each Estate may be due to each of the Complainants and that they settle the same between them as they are respectively entitled by the orders of said Richard and Benjamin Edwards having regard to any payments having been made to any of the Complainants and that they make a report of their doings and things in this behalf in order to a final Decree
