probably be overflowed, and say to what damage it will be of the several proprietors and
whether the Navigation course of any such proprietor or the offices, cartilage or houses
thereunto immediately belonging, or orchards will be suffered to injure whether and in
what degree fish of passage and ordinary navigation will be obstructed and otherwise
their opinion the health of the neighborhood will be annoyed by the stagnation of the waters
and that the report so to be made be sealed by the said Juries together with this
writ be returned by the said Sheriff to the next Court -
