Martha Johnson is by the Court appointed Successor to the Johnson orphan of Robert Johnson deceased who together with William Lawrence and Eliza Dargent his Legatees entered into and acknowledged their bond in the penalty of Three Thousand Dollars conditioned as according to law

The last will and Testament of William Blith deceased was proved by the oath of John Lister one of the witnesses thereto the testator therein named refusing to take upon himself the burden of the execution thereof saw the Notary of Benjamin Nelson who was then and together with John Lister and Lambeth Earle his securities entered into and acknowledged their bond in the penalty of Five thousand dollars conditioned as the Law directs certificate to be granted him for obtaining letters of administration on the said deceased Estate with his wife affidavit annexed in due form

The last will and Testament of Francis Harris deceased was proved by the oath of William Mahouse one of the witnesses thereto and the said witness being sworn did swear touching the said last will and Testament whereupon it is ordered that the same be recorded as a personalty On the motion of Mr. Slingsby Smith the executor named in the said will whom made oath thereto and entered into and acknowledged his bond in the penalty of Two thousand dollars conditioned as the Law directs certificate is granted him for obtaining a probate thereof in due form the will meeting that no Security to be given of the sum for his executatorial proceedings

Order that Richard Harrison Law<sup>r</sup> Arthur Williamson, William Smith and Jacob Remond or any three of them being first sworn before a Notary Public for that purpose do appear in Court Money the sum of any and personal Estate Francis Harris deceased are returned the affidavits to the Court

The last will and Testament of Elizabeth Pipe deceased was proved by the oaths of the witnesses thereto and is ordered to be record on the motion of said William the testator thereto named who made such Testate and together with Lewis Pipe and George Moller his Legatees entered into and acknowledged their bond in the penalty of fifteen hundred dollars conditioned as the Law directs certificate is granted him for obtaining a probate thereof in due form

Ordered that these be done before a Notary Public and to the Court
