Alec Williams and Benjamin Harrison are appointed to lay out the said pre-empted in present No. 3. beginning and bounded by Tobacco River and the flat swamp and from the old Parish line to the flat swamp East up to Thomas Cooks and thence to the beginning. Alec Tuth Nicholas and Benjamin Jones are appointed preceptors in present No. 4. between the Indian Line, Rattaway River, the two creeks and the creek roads. —
Nathaniel Williams and Neesh Harris are appointed preceptors for the Precinct No. 5 beginning at the Indian bridge up the swamp to Townsend branch up the said branch to the Angeline Chappell down down Tobacco road to the head of Buckhorn down that to the new road and by the said road to the beginning. —
Bournebury Denny and John A. Richmonds are appointed preceptors for Precinct No. 6 beginning at the mouth of Rileys branch to the head of Orange branch, down that to River Meadow up that to Robin branch up that to the head of the Angeline swamp and down the said swamp to the beginning. —

Benjamin Blythe Jr. and Peter Blythe are appointed preceptors for Precinct No. 10 beginning at the mouth of Blounts swamp up the said swamp up that to the Indian line down the said line to Coffers road up the said road to flat swamp and up the same to the beginning. —
Henry Rolan and James Mould are appointed preceptors for Precinct No. 11 beginning at the Parish line at the flat swamp down the said swamp to the mouth of Blounts swamp up the said swamp to the mouth of Ross swamp up that to the Indian line along the said branch to Townsend branch down that to the Angeline swamp up that to the head of the Cabin branch down said branch to the old Parish line thence to the beginning. —
Jacob Bennett and Jordan Bennett are appointed preceptors for Precinct No. 12 beginning at the old County line on the South side of the Coffers swamp and up the same to Borne Road, along the said road to the County line, down the same to the County line, thence to the beginning. —
Richard Blythe and Thomas Cooks are appointed preceptors for Precinct No. 13. beginning at the County line at Borne road up the said line to the mouth of the flat swamp up that to Joseph Conitts thence — along Taylors road to Whitehead path, thence down the said path to the Coffers swamp, down through said swamp to Borne road up the said Road to the beginning. —
Antony Bryant and John Bennett are appointed preceptors in Precinct No. 14 beginning at James Conitts along Taylors road to John Conitts swamp up the same to Coffers road and up the said road to the flat swamp and down the said swamp to the beginning.
