and Nathaniel Lane Notary Public of this said County of Franklin certifying the acknowledgment  
of the said Anna Maria Wall in presence of an Act of Assembly no such Care made and  
provided and annexed to record.

Benjamin Coffey is by the court appointed a trustee in the County of Franklin and

her for bearing a fidelity thereof in due form.

Ordered that Jacob Powers, Sife Landford, William Dugay and John Cobbell or any three  
of them being first sworn before a Justice of the Peace appear in court upon the  
day of any and personal service of William Atkinson deceased and return the Office  
ment to the court.
