The Persons appointed by a former order of this Court, precipice masters in Precinct No. 11. This day made this report in the words and figures following (to W.M.)

"Agreeable to an order of Southampton Court, bearing date July 1865, Mr Henry Porter and James Morris, set on the first on the 2nd lines on the 4th day of March last, Precipice all the Land from the former Parish line, at the first Turnpike, down the said Swamp to the mouth of Blund Swamp, up the said Swamp to the mouth of Rose Swamp, up said line Swamp to the main line, along the said Branch to the Town Branch, down that to the anglies Swamp, up said Swamp to the head of the ballin Branch down said ballin Branch to the old parish line, then to the Beginning. Present on the 15th day of March, John Edmund, Conwell Stephen, William Brigham and Nathan Lamp, Present on the Second day of March, John Ellins and John Edmund. Present on the 4th day of March, John Edmund, Turner, Morris, Samuel Francis, and Chapman Barnes & Lamp. Given under our hands this 15th day of April 1866, Henry Porter, James Morris" Which was done to be Retained.

The Persons appointed Precipice masters by a former order of this Court in Precinct No. 23. This day made this report in the words and figures following (to W.M.)

"Agreeable to the within order now directed bearing date July last 1866, to the amount and have precipiced all the Land within the bounds mentioned and described as the within order. Except the line between Jacob Turner and Dennis Turner, left the Precipicing by Edmund Turner, all the People now present within the bounds aforesaid during the time, except James Jackson, Worcester Hills and Cassel Branch. Given under our hands this 20th of May 1866 - No more than one half day completing the Precipicing. Miller Francis, Davis Keween." Which was ordered to be recorded.

The Persons appointed Precipice master by a former order of this Court in Precinct No. 29. This day made this in the words and figures following (to W.M.)

"Agreeable to an order of the County Court of Southampton to set aside, Mr. de unisoned Precipice & Precipice between the 15th of February and the last day of March, as the order required in all have Precipiced all the Land between Black water, the Old Parke line and the Cuffee Swamp within the limits thus mentioned thereon, Except a line between John Lawrence and Elizabeth Whiting which line was not precipiced, in consequence of the said John Lawrence now attending the cause of his not attesting his known fact. Also a line between Joseph M. Ballard and Doctor Lawrence not Precipiced in consequence of neither of them attending, but the line not reported as not known of. Given under our hands the 14th day of May 1866. Ipe Lambford, William Joyner" Which was ordered to be recorded.
