Carter, Amos Jackson, Anthony Bond, George Fogg, William Sells, Alex. Bond
Samuel Turner & Mills Bond, Joseph Keftman and Aaron a few negro who are
free holders and house keepers, have seen all the lands procured by the said District
No. 2, except a disputed line between, Michael Bond and David Day, beginning at a
Walnut tree and ending at a Pine which was refused by Michael Bond, and from then
engaged in performing the same 4th day, James Sizer and hands this 27th of
March 1846, (MD) Nearly about one day and a half, James Jackson, John Bond
Which was ordered to be recorded —

One document of his own said John Newman, William Newman of the same part and
Jelly Newman of the other part were acknowledged in presence by the said William
Newman and ordered to be recorded —

The last will and Testament of Lucy Biddle decedent was proved by the oath of James
bottom one of the witnesses thereto and having been before proved by the oath of Biddle bottom
another witness, which is ordered to be recorded —

James D. Hapenburg, Peter Bother, Thomas Bother, John Brown, Benjamin Turner
and John Bond, all by the Court recommended to the Gallatin Prison, James
James Turner a Slave Negro trader of the Commonwealth a full power to sell to the
Commissioners of the State for this County —

About James Davis, John Brown, Jacob Davis, Benjamin M. Hunter, Francis
Riley, and William Bailey Clerk Justice —

Ordered that John Partridge, Lawrence Bond, William Francis and others who are any
two of them as witnesses take and tell the account of the administration on the estate of
Madison Bond decedent and make a report during of the Court —

Henry Bailey, Peter Brown, Lewis R. Bond, Henry Miller and John (all of them) proved
to the Court a receipt of the debt for the day imposed by law on occasion, that they
be permitted to give security at their respective homes until the first day of May next
ensuing upon their giving bond and security in the clerk's office according to law —

Ordered that John Bond, John Rother, and James Rochelle, or any two of them, as real
out the old Run house, standing on the public ground, for the best price that can be obtained
for five years expiring, taking hand or bond with approval security for the
due and full payment of the said rent annually, and that day or days of them
as may act make a report thereof to the Court —
