Williams Green, Atholius Monroe and Eliza Scott or any three of them being first sworn before a Justice of the Peace of this County do appear in court to arrest money the sum of any one thousand Dollars of the estate of Sarah Doyal deceased and return the appearance to the Court.

The Persons appointed Procurion masters are Precent No. 13 by a former order of the Court the day made their report in the words and figures following to wit "Agreeable to the above order to be directed, first have procurion the three written in this hands directed, without dispute, having John Scott, John Drury, John Williams, John W. Teller, Alfred Johnson and Eliza Scott Procurer, being three days employed at \$2 per day for sum of \$6. Paid John Scott, Richard P. Clements, which was ordered to be Recorded.

On the motion of Abielson Reed whose are with another who with Lewis Ross and George Day his Securitie entered into an acknowledgement & bond in the sum of five hundred Dollars, conditions as the law and certificate is granted him for obtaining letter of administration on the estate of Polly Day deceased in due form.
