of the Court by the affidavit of Joseph Lauter Deputy of Henry Blingy that the

not. Therefore it is concurred by the Court that the Plaintiff may have execution
against the said Defendants for Twenty Six Dollars and fourtene Shillings the Penalty
of the said bond and his costs by him about his suit in this behalf expended and
the said Defendant in Mercy &c. But this Judgment is to be discharged by the
payment of Thirty Eight Dollar and Seven Shillings with Interest thereon to be computed
after the rate of Six per Centum per annum from the fourteenth day of September 1810
until the time of Payment and the costs aforesaid —
