This day came the Parties by their attorneys and it appearing to the satisfaction of the Court by the affidavit of Joseph Blanton deputy of Henry Briggs Sheriff, that the defendants have had legal notice of this motion They were solemnly called but came not Therefore it is considered by the Court that the Plaintiff may make execution against the said defendant for Seventy Five dollars and fourteen cents The penalty of the said Bond and his costs by him about his suit in this behalf expended, and the said defendant in money &c But this Judgment is to be discharged by the Payment of Thirty eight dollars and six cents with interest thereon to be computed after the rate of Six per centum per annum from the fourteenth day of September 1816 until the time of Payment and the costs
