

of her natural life one third of the Haver wherof John Day was proprietor which may be delivered to them by the defendant Edwin Turner administrator of said John Day, having regard to their value as and for her dower in the same, and that they or any two of them, do then divide the balance of said Haver into five equal Parts having regard to value and allot to each of said Plaintiff Richard B Day, Thomas L Day, John M Day and Francis D one equal Part and the remaining fifth part to Edwin Turner administrator of his late wife Martha I decreed the right of demanding refunding bonds from the Plaintiffs or the guardians of each of them as arising being reserved to the said defendant Edwin Turner as administrator of the said John Day deceased And it is further ordered that they or such of them as may act do make a report to this Court in order to a final Decree

Ordered that John Clayton, Jeph Vick and James Pond or any two of do examine State and settle the accounts of the administration on the Estate Lucy Willson deceased and make reports thereof to the Court
