"Agreeably to an order of the County Court of Southampton to us directed
bearing date - We the undersigned have gone on the lands of Jacob Corbett
decd. and surveyed the same and find there to be 389 acres 70 acres of which
we have allotted of and apportioned over to Rebecca Corbett widow of Jacob Corbett
decd. as by the order we were required having regard to quality as well as
quantity by proper rules and bounds as follows, To wit, Beginning at a pine
corner of Barr Bowers and Joseph W. Ballant, thence S. 52. W. 130 poles to an
old light wood stump a corner in Jeffs Jeffs Land for line, thence N. 42.
W. 142 poles Variation on the line: thence N. 14. W. 120 poles to a corner post in
the orchard, thence a new corner made from that post inclining part of the
orchard and all the landings except the privilege of one part of the same
which was excepted for the benefit of the orphans of Joshua Corbett and
thence S. 168 poles to a new corner made in Miller Daniel and line, thence
